#### Brief CV of the speaker:

Cecilia Malmström was a European Commissioner from 2010 to 2019, first responsible for home affairs and, from 2014 to 2019, for trade policy. She led the trade negotiations with the Mercosur countries, Canada and Japan. She was the Swedish Minister for European Affairs (from 2006 to 2010) during Sweden's Presidency of the Council of the European Union in 2009, responsible for the EU Baltic Sea Region Strategy. Malmström was a Member of the European Parliament between 1999 and 2006, during which period she was, among other responsibilities, a member of the Committee for Foreign Affairs and the Subcommittee on Human Rights. Malmström is a non-resident Senior Fellow with the Peterson Institute for International Economics in Washington, DC and she holds a doctorate from the University of Gothenburg.

# 4) Call for Papers: Aleksanteri Conference 2022 "The New Era of Insecurity: How Russia's War in Ukraine Changes the World"

21st Annual Aleksanteri Conference

THE NEW ERA OF INSECURITY: How Russia's War in Ukraine Changes the World

**Dates and venue:** The conference is being planned to be held in-person from 26 to 28 October 2022 and will be hosted at the University of Helsinki, Finland. We will provide a limited number of panels with the possibility to arrange their panels virtually, and participants with the possibility to follow the conference online.

Russia's unprovoked and illegal military attack against Ukraine in February 2022 has caused immense destruction and human suffering that will leave deep scars in Ukraine. This war will also have long-term repercussions for European and global security. The world community has condemned Russia's actions and agreed upon sanctions that target Russia's ability to continue the war in Ukraine. Consequently, Russia's economy has taken a blow that, together with the political consequences of Russia's war, may change Russia's status in the world. At the same time, the Kremlin has introduced new regulations to suppress civic activism in Russia, resulting in a mass exodus of people from the country. Consequently, we have decided to reformulate the original conference theme about Russia and global insecurity into a specific question on how Russia's war in Ukraine will change the world.

The 21st Aleksanteri Conference to be held in October 2022 provides a forum to seek answers to this and other relevant questions with researchers specialising in Russia's foreign and military thinking, as well as information, cyber and energy security. The conference also welcomes research contributions on politics, security and civil society in Ukraine, as well as in Russia, and Eurasia.

Russia's war in Ukraine will also change the way in which current and future scholars will study the region. The suspension of cooperation between Western and Russian research institutes and the forced evacuation of scholars from Ukraine means limited access and resources for conducting research in Russia and in Ukraine. At the same time, we need to critically assess the theoretical and

methodological underpinnings guiding the research that will help to understand this new era of insecurity and its meaning for Europe and the world.

Taking into account the principles of engagement agreed upon by Universities Finland UNIFI and guidelines of the University of Helsinki on collaboration with Russia and Belarus, the conference organisers wish to note the following:

- No proposal or presentation advocating for Russia's war on Ukraine will be accepted.

- Colleagues based in Russia or Belarus will participate in a personal capacity only, meaning that we will remove institutional affiliations from the conference programme.

The conference organisers encourage Ukrainian scholars to participate in the event. For this purpose they are exempted from paying the conference fee.

In addition to plenary sessions, the conference features scientific panels, roundtables and a poster session. Complementing academic activity, the conference programme will include various activities for networking: cultural events, evening receptions, a guided walking tour in Helsinki and visits to museums and the Slavonic Library. We will also organise a book exhibition at the main conference venue.

#### Submissions:

The deadline for submitting paper, panel and roundtable proposals is 29 May 2022.

All abstracts must contain the following information to allow a sound referee review:

- Abstract title
- Abstract structure: aim, background, methods, findings and conclusion/recommendations
- Abstract text in English within the given word limits
- All authors' and co-authors' names and affiliations
- Contact information (name, email address) of corresponding author(s)

**Individual paper proposals:** Please submit your individual abstracts of 300-500 words via the <u>paper</u> <u>submission</u> form. The organisers will form a limited number of thematic panels from the highestrated individual proposals. We except that these panels will take place in-person at the conference venue.

**Panel proposals**: Panels should consist of three paper presenters, a chair and a discussant (or four paper presenters and a chair). Panels must aim for an international composition. Panel sessions will take place from Wednesday to Friday at the conference venue. As a rule, one of the speakers of the panel can participate remotely, while others will give their presentations in-person at the conference venue. Chairs should be present at the conference venue. We will also provide a limited number of panels with the possibility to organise their panels completely virtually. Parallel virtual sessions will take place on the Wednesday and Thursday afternoons. Preferred option is to organise in-person panels at the conference venue. Please submit your panel proposal, including an abstract of 300-500 words and information on the form of participation, via the <u>panel proposal submission form</u>.

**Roundtables:** Each roundtable will feature a structured discussion on a timely theme or problem that requires a more open format of debate than a conventional paper session. Roundtables must have a moderator and three to five speakers. As a rule, one of the speakers of the roundtable can participate remotely, while the others will give their presentations in-person at the conference venue. Moderators should be present at the conference venue. We will also provide a limited number of roundtables with the possibility to organise their sessions completely virtually. Parallel virtual sessions take place on the Wednesday and Thursday afternoons. Preferred option is to organise in-person roundtables at the conference venue. Please submit your roundtable proposal, including an abstract of 300-500 words and information on the form of participation, via the roundtable proposal submission form.

All abstracts will be reviewed and rated by scientific experts for abstract quality and presentation content. Notification of acceptance for paper, panel and roundtable proposals will be sent via email by 30 June 2022. Abstracts of accepted papers/panels/roundtables will be published on the conference website.

Participants from Ukraine are exempted from paying the conference fee.

#### **Guidelines for sessions:**

Panel sessions will last 90 minutes each and shall be structured as follows:

Oral presentation: 15 min (in panels with 4 papers) or 20 min (in panels with 3 papers)

Discussant's comments: 10 min

Q&A: 20 min

The chair will introduce the panel and its participants, proceeding to make sure that time is allocated equally between individual presenters. The chair is responsible for providing equal participation for online and in-person presenters. The discussant will have 10 minutes to give their comments after all panellists have presented their papers.

Roundtables will also last 90 minutes. Please be mindful of time constraints so that we can achieve a fair allocation of time between participants.

#### **General information:**

As of April 2022, the conference is being planned to be held in-person with a limited possibility for online participation. We will follow the safety protocols that are effective at the University of Helsinki during the conference. More information will be available when registration opens in June.

The working language of the conference is English. Unfortunately, no translations can be provided. There is a PC and projector in every lecture hall.

#### **CALL FOR PAPERS**

EUROPEAN YEARBOOK OF CONSTITUTIONAL LAW (EYCL), VOLUME 5 (2023)

#### CONSTITUTIONAL LAW AND THE ALGORITHMIC STATE

The European Yearbook of Constitutional Law is pleased to announce a call for submissions for its fifth volume (2023) on Constitutional law and the algorithmic state.

The emergence of new, machine-oriented technologies surpassing individual human capacities has brought the administrative state to the next level: the algorithmic state. In such a state, algorithms are used to support or automate regulation and administrative decision-making processes. Algorithmic law- and decision-making ranges from the use of simple, code-driven, rule-based algorithms, such as (blockchain-based) smart contracts, to complex self-learning algorithms based on 'big data' and artificial intelligence. Algorithmic law- and decision-making impacts constitutional values and fundamental principles of constitutional law, such as legality, the separation of powers, fundamental rights, democracy and effective judicial control. Whereas on the one hand digitalisation impacts constitutions and constitutional values, constitutions and constitutional values on the other hand may also affect digitalisation by means of regulation. The primary goals of this volume of the EYCL are (i) to interrogate the constitutional challenges arising from the algorithmic state, and (ii) to analyse and develop potential responses and remedies that constitutional law can provide to face the algorithmic society.

The EYCL therefore invites scholars to address the theme of this call for papers and welcomes contributions devoted, but not limited to the following:

• the effects of digitalisation and new technologies on the structural aspects of states, such as the separation of powers and checks-and-balances;

• the effects of digitalisation and new technologies on fundamental rights, such as (but not limited to) the right to privacy and freedom of expression;

• the impact of the attenuation of the traditional distinction between rulemaking and decisionmaking due to the rigid, automated application of algorithmic rules on the level of discretionary power of administrative authorities and on the level of deference of (administrative) courts;

• specific (disruptive) technologies, such as artificial intelligence, blockchain, robotics, the automation of justice, or specific case studies of any of these technologies, and their effects on constitutional law;

• normative counterreactions to face the challenges of digital technology, including digital constitutionalism;

• contributions that more broadly discuss the regulation of technologies and/or regulation by technologies (by-design, law as code).

Authors are warmly encouraged to take a multi- and/or interdisciplinary approach. We also welcome publications that take (or combine) different methodological approaches, such as legal doctrinal research, comparative constitutional legal research or empirical qualitative or quantitative research.

DEADLINE FOR PROPOSALS: 1 June 2022, although earlier submissions are encouraged.

**PROPOSAL SUBMISSION:** Proposals of 350 to 500 words should be submitted to eycl@uvt.nl. Please put "Proposed paper, volume 5" in the subject line of your email. Successful applicants will be notified by 1 July 2022. Complete papers must be submitted by 1 December 2022. Manuscripts should be no longer than 10,000 words, including footnotes. In preparing their manuscript, authors

should follow the EYCL Style Guide, which will be sent to them when notified about their successful application. Decisions to publish a submission are based on editorial and double-blind peer review.

**ABOUT THE EYCL:** The European Yearbook of Constitutional Law is an annual publication devoted to the study of constitutional law. The Yearbook provides a forum for in-depth analysis and discussion of new developments in constitutional law in Europe and beyond. Each issue is dedicated to a specific theme. The inaugural volume of the Yearbook (2019) was entitled 'Judicial Power: Safeguards and Limits in a Democratic Society', volume 2 (2020) was devoted to 'The City in Constitutional Law', volume 3 (2021) to 'Constitutional Advice' and volume 4 (2022) to 'The Constitutional Identity of the European Union'. #### Offer description

The University of Liège (Belgium, founded in 1817) has a long-standing tradition in cutting edge research in the field of European Union (EU) law. Within the "Cité" Research Unit embedded within the Faculty of Law, Political Science and Criminology, the EU legal studies research group presently constitutes an interdisciplinary team comprising about 15 researchers working on the intersections between EU law and related disciplines (economics, information technology sciences, social sciences).

As of September 2021, the group hosts the ERC StG project EUDAIMONIA (GA: 948473, https://cordis.europa.eu/project/id/948473). That project seeks to map the impact of European Union law obligations on national administrative organisation designs across 18 sectors influenced by EU regulation. They are expected to become the faces of the ERC project. We offer a PhD scholarship contract of up to 4 years and a competitive salary in accordance with the University's salary scales. Candidates will receive a net salary of €2059 per month, in addition to full reimbursement of public transportation in Belgium and meal vouchers up to €76 per month.

Selected PhD candidates will have the opportunity to work on an important European research project, of which you will become one of the faces.
