Analytical report “Academic reputations and social portraits of Russian legal scholars” released

The Institute for Law Enforcement Issues has released an analytical report “Academic Reputations and Social Profile of Russian Legal Scholars.” The report is based on Russia’s first large-scale representative survey of legal scholars. The survey was conducted jointly with the EUSP CIANO and the scientific electronic library Elbrary.

Based on the results of the survey, ratings of the most authoritative figures who contributed both to Russian legal science in general and to individual branches of law were built. The report analyses how the received reputation ratings correlate with bibliometric indicators. In addition, the opinions of respondents on debateable issues in the field of law are analyzed. The authors also give a detailed social portrait of the academic community of lawyers: demographic characteristics, geographic and labor mobility, teaching load, involvement in legal practice and the degree of integration into international sciences.
