Among the topics are: The United Nations (Broms), Selected Problems of International Humanitarian Law (Green), Informal Agreements in International Law (Klabbers), Reform of the European Convention on Human Rights (Kosonen), Environmental Protection and the European Community (Mahmoudi), State Succession (Prokhorov), European Community and National Jurisdiction (Rudolf), Universal Human Rights - Substantive Law and Mechanisms of Implementation (Tomuschat).

## **PROGRAM**

The lectures and seminars are given in English. The Summer Seminar will be held at the Porthania Building of the University of Helsinki (Hallituskatu 11-13, FIN-00014 The University of Helsinki). During the Summer Seminar it is possible to obtain two different kinds of Certificates: 1) Certificate of Active Attendance and 2) Certificate of Successful Examination on International Law (The Seminar Diploma). The Seminar consists of courses and Seminars. Diploma candidates are also obliged to participate in the Seminar Examination.

## **ADMISSION**

To obtain admission to the courses, one has to register by filing in a registration form or by sending the application of attendance preferably before August 1, 1994. There is a registration and tuition fee of 300 FIM which should be paid in advance at the time of registration.
