PROGRAM

The lectures and seminars are given in English. The Summer Seminar will be held at the Main Building of the University of Helsinki (Fabianinkatu 33, Helsinki). During the Summer Seminar it is possible to obtain two different kinds of certificates: 1) Certificate of Active Attendance and 2) Certificate of Successful Examination on International Law (The Seminar Diploma). The Seminar consists of courses and seminars. Diploma candidates are also obliged to participate in the Seminar Examination.

ADMISSION

To obtain admission to the seminar, one has to register by filling in a registration form or by sending the application of attendance by 1 August 1996. There is a registration and tuition fee of 500 FIM which should be paid in advance at the time of registration.
