HYVÄT received a total of 63 applications for 29 doctoral programmes. 4 programmes are without

applications, and 8 with only one application. One programme had two applicants who did not demonstrate sufficient motivation, so their applications were rejected. For those 13 programmes, HYVÄT will reopen the

call and continue to search for applicants in collaboration with the programme coordinators.

The main criteria used for the selection of application were the candidates' motivation and their possible

relevant experience for the position. The selection committee also aimed to have a diverse representation
